The Grace Brethren Christian School Oversight Program is recognized by the State of Maryland as a bona fide Home School Umbrella Program. Our primary responsibility is to assure that you, the home school parent/s, are providing “regular, thorough instruction...” to your children. Our services depend in part on your needs as a teacher. We offer

minimal support for the more experienced home school family or a more intensive supervisory program if required.

Minimum Requirements and Services

- Fill out an Application Form and return it to Grace Brethren’s Education Office. Be sure to include the \$40 non-refundable Application Fee. If this Fee is not submitted with your application, we cannot initiate enrollment for your student.
- Complete the Assurance of Consent form provided by your county’s Board of Education. This is your protection against truancy charges. Should you choose not to file this form, Grace Brethren will not be held responsible.
- Maintain a portfolio for each child containing Objectives and Methods, a Curriculum List, a Reading List, test results, and a weekly sample of each student’s work per subject, **dated and in order**. There are several important reasons for this requirement. This portfolio is required by law; it is the parents’ proof of compliance with the law; and it is helpful to the parent and student to see gradual progress. Parents should keep the portfolios updated **weekly**. High School students are also required to complete service hours each year.
- Participate in the required Testing as determined by Grace Brethren Christian School. Students in 9th, 10th and 11th grades must be tested to be certain they are meeting the required standards in order to receive a diploma from Grace Brethren Christian School. The actual test dates are listed in the school calendar, which will be handed out at the **August Orientation Meeting**. **YOU MUST REGISTER EARLY**. The fees vary:

Achievement Test	\$40 (all grades)
PLAN Test/10th	\$12 or Actual Cost
PSAT Test/11th	\$13 or Actual Cost

- Provide grades for our records at the end of each quarter. The quarter breaks run parallel with those of GBCS. **Grades** are **due** within **7 days** and can be mailed to the Home School Coordinator or dropped off in the Education Office. Failure to submit grades in a timely manner could result in being dropped from the Umbrella Program. **Please note:** If a quarter’s worth of work has not been completed in any subject, please use an “I” (for Incomplete) until such a time as the work has been finished. You may call me with the grade or make the correction on the next report card. Incomplete work should not receive a grade.
- High school students are required to take certain classes on campus in order to graduate. They include Speech/Composition (10th and up) and Worldviews in 12th grade.

- Grace Brethren Christian School Oversight Program is required to review your curriculum/portfolio a minimum of two times each academic year. **Call** the GBCS Home School Director at 301-868-1600, ext. 329, **to schedule** your appointments at the beginning and the end of the school year.
- Pay the following **REGISTRATION FEES**:
 - \$ 185.00 for each SENIOR (12th grade)
 - \$ 135.00 for each student in 7th to 11th grades or the 1st Elementary student
 - \$ 75.00 for each additional Elementary child in the same family

OPTIONAL SUPPORT SERVICES

- Students may take up to two courses per semester on campus on a space available basis. The **semester cost** per class is as follows:
 - \$225.00 per student for grades 1-4 (\$425 per year if paid up front)
 - \$375.00 per student for grades 5-8 (\$725 per year if paid up front)
 - \$400.00 per student for grades 9-12 (\$775/year up front for a 1 credit class)
- Payment is due **BEFORE** the beginning of each semester, or a **\$35 late fee** will apply and will be added each month there is still a balance on the account. Consumable workbooks and/or lab supplies will incur an additional fee. Any student wanting to take more than 2 courses should enroll as a full time student and pay the normal Tuition and Fees. **School behavior and dress codes apply at all times.** The student may only be on campus for the actual class s/he is taking, may NOT roam the halls during class, and must be picked up promptly afterwards. CD players or electronic devices of any kind are not permitted on campus; phones must be turned off and out of sight. Inappropriate pictures, magazines, lyrics, drawings, etc., are also not allowed.
- After school **SPORTS** are available to your child at a cost of **\$140.00** per sport (maximum of \$280 per child per year). Participation is based on available space and/or a successful tryout. All students are required to get a physical first. The forms are available from the school. Some of the extracurricular activities include: Soccer, Cross Country, Volleyball, Basketball, Baseball, Softball, Tennis, Track, and Cheerleading. A release must be signed by the Home School Director indicating that the child is a bona fide home schooler, enrolled in the GBCS Umbrella Program, having passed the required physical and paid all the necessary fees **before** the child may participate in any practices or games. A student who is enrolled full-time at another school, whether public or private, does not qualify as a bona fide home schooler in the GBCS Umbrella Program.
- **Field Trips:** Available information is posted on updates that are sent out by email. Elementary field trips are limited and the cost varies. A signed Permission Slip must be handed in. Parents of Elementary children must go along as chaperone, unless the student is already taking a class at GBCS, and you will have to drive your own vehicle. Middle and High School trips are course related, so only students taking that specific class would be able to attend the field trip. School behavior and dress codes apply at all times when on campus or participating in any GBCS activity. There is a **school-wide “NO GUM”** rule.

ADMISSIONS POLICIES AND PROCEDURES

1. Parents must subscribe to the Grace Brethren Christian School Statement of Faith and desire to cooperate with GBCS in the development of their child so he/she will become a maturing Christian.
2. One parent must be available at home to supervise the home school program and the progress of the child.
3. Both parents must view the home schooling of their children as a spiritual commitment
4. Parents must consistently meet educational objectives - including testing, submitting quarterly grades, and keeping an up-dated portfolio - in order to continue in the program. Financial obligations must be paid in full.
5. At least one parent must be a born-again Christian.
6. At least one parent must faithfully attend a Bible-teaching church. Students are to be involved in church group activities such as Sunday School, Awana, Youth Group, etc.

ENROLLMENT PROCEDURES

1. Complete the “Home School Application” and “Information Regarding Student” pages in your Application Packet for **each child** enrolling. Read and sign the “Home School Parents’ Agreement” and “Enrollment Requirements” forms. Return these forms to the Home School Director with the non-refundable Application Fee of **\$40.00 per student**.
2. Upon completion of your admission file (application, required forms, and \$40.00 fee), you will be scheduled for an interview by the Home School Director.

HOME SCHOOL PARENTS' AGREEMENT

In signing this application, I/we acknowledge the following:

Our commitment to participate in the Christian education of our child with regular attendance at a Bible-believing Church as a family and by exemplifying Christian principles of life in our home.
